**RESOLUTION
THE GOVERNMENT OF THE CZECH REPUBLIC**

of 15 March 2020 no.
on the adoption of a crisis measure

Following Government Resolution No. 194 of 12 March 2020, by which the Government, in accordance with Articles 5 and 6 of Constitutional Act No. 110/1998 Coll., On the Security of the Czech Republic, declared for the territory of the Czech Republic, in connection with proving the occurrence of coronavirus / referred to as SARS CoV-2 / in the Czech Republic, the state of emergency, and a) to e) and § 6 of Act No. 240/2000 Coll., on Crisis Management and on Amendments to Certain Acts (Crisis Act), as amended, to resolve a crisis situation, decided to adopt crisis measures, in accordance with the provisions of § 5 let. 6 (1) (c) and § 6 (1) (a). b) of the Crisis Act:

The Government, with effect from 16 March 2020, from 0:00 AM to 24 March 2020 until 6:00 AM:

I. **prohibits** the free movement of persons throughout the Czech Republic, except:

- a) travel to work and to the pursuit of a business or other similar activity,
- b) the necessary journeys to family or close relatives;
- c) journeys necessary for the provision of basic life needs (e.g. purchase of food, medicines and medical devices, sanitary goods, cosmetics and other similar goods, animal feed and other supplies for animals), including the needs of relatives and close persons, ensuring childcare, provision of animal care, use of necessary financial and postal services, refuelling,
- d) journeys necessary to meet the needs and services referred to in point (c) for another person (e.g. volunteering, neighbourhood assistance);
- e) travel to health and social care facilities, including the provision of necessary escorts for relatives and close persons, and veterinary care facilities;
- f) journeys to deal with urgent official matters, including the necessary escort of relatives and close persons;
- g) the pursuit of the profession or of the reinsurance following activities
 - 1. security, internal order and crisis management,
 - 2. health protection, health or social care provision, including volunteering;
 - 3. individual spiritual care and services,
 - 4. public transport and other infrastructures,
 - 5. services for persons, including supply and distribution services,
 - 6. veterinary care,

- h) stay in nature or parks,
- i) travel back to his/her place of residence;
- j) funerals;

II. orders

- a) persons residing in the territory of the Czech Republic to restrict movement in publicly accessible places for as long as is necessary and to reside in their place of residence, except in the cases referred to in point I (a); a) to j),
- b) limit contacts with other persons to the extent necessary;

III. recommends

- a) employers
 - 1. use as far as possible teleworking, if employees can do it at their place of residence;
 - 2. to promote leave and paid leave for employees and similar instruments provided for in the collective agreement;
 - 3. restrict the performance of work that is not significant to the maintenance of the employer's activity;
- b) maintain a distance of at least 2 meters in contact with other persons in public areas (e.g. when purchasing);
- c) use non-cash payments for hygienic reasons,
- d) persons providing the services referred to in point I (a); g) limit direct contact with customers,
- e) public service operators (e.g. shops, shopping malls, post offices), in their premises and in the premises used to access the premises:
 - 1. create conditions for keeping a distance of at least 2 meters between persons,
 - 2. ensure increased hygiene measures (in particular disinfection).

IV. cancels

- 1. point I. 1. of the Resolution of the Government of the Czech Republic No. 199 of 12 March 2020.
- 2. point 2 of the Resolution of the Government of the Czech Republic No. 208 of 13 March 2020.
